

It is requested that Metropolitan Division, Underwater Dive Unit, be approved for funding for the instruction and certification of three Open Water SCUBA Instructors. Approval of this grant benefits the Department as follows:


The Underwater Dive Unit (UDU) is responsible for processing all underwater crime scenes related to Los Angeles Police Department investigations. The UDU is also responsible for waterborne body recoveries, evidence recovery, waterborne suspect apprehension, critical infrastructure screenings and port security missions, waterborne vehicle recovery, and other missions, many of which are multi-jurisdictional. The UDU conducts almost all of its training in-house. The UDU also facilitates and conducts training for the Special Weapons and Tactics Tactical Waterborne component and Emergency Services Division's Bomb Squad divers. Currently the UDU has three certified SCUBA instructors. One of those instructors will retire in February 2022. At one point, the UDU had a total of eight instructors, who were responsible for training nearly 50 Department divers. Over the past several years, the number of instructors has diminished through retirements. The last time that funding was sought for this purpose was in 2008. In order to maintain the professionalism and proficiency of the Department's diving program, it is imperative that the UDU develop additional SCUBA instructors.

This instructor training will be provided by a course director from an approved dive training agency.



It is requested that the Underwater Dive Unit be permitted to utilize funds for boat maintenance and equipment.


Approval of this grant benefits the Department as follows:
